## The Purpose

Eight days/Seven nights landscape photography and videography Workshop in the Lofoten Islands, Norway, from January 31st to February 7th, 2025, and/or from February 9th to 16th, 2025.

## Governing Law/Jurisdiction

The Workshop operates in accordance with Spanish law and jurisdiction.

## Services Included in the Workshop

- Photography Workshop, individual coaching and photography feedback by an experienced professional photographer and the Director of Nomadict throughout the program
- Transfer from/to the Leknes airport in Lofoten on January 31st to February 7th, 2025, and/or from February 9th to 16th, 2025.

- Seven nights in an accommodation in the Lofoten Islands, single room, shared living room, kitchen, and bathroom.
- Travel security certificate

### Services Excluded from the Workshop

- Flights
- Pre- and post-travel arrangements
- Passport and Visa expenses
- Government arrival and departure taxes
- All meals
- Travel insurance (strongly recommended)
- Excess baggage charges and all items of a personal nature such as laundry, bar, beverage charges, and telecommunication charges
- Extra activities
- Anything not mentioned in “Services included in the Workshop”

### Workshop Price

- €3900, if booked before or on 30th September 2024
- €4500, if booked after 30th September 2024

### Terms of Payment

The accepted payment methods include bank transfer (no additional cost on the Workshop Leaders' behalf) or via Visa/Mastercard (a 1.5% fee may apply). Participants must cover the exchange rates and transfer fees. The transaction is charged in EURO. Final payment is always conducted in EURO. Refunds are also conducted in EURO.

### Cancellation Policy and Refunds

#### PAYMENT POLICY:

- 40% initial deposit to secure the Workshop spot - non-refundable
- 60% final balance by November 1st, 2024 - non-refundable
- If the participant books less than 30 days before departure: a single payment is required and the Workshop price is non-refundable.

#### CANCELED WORKSHOP:

If there are any complications with traveling or uncertainties arising that may impact the participants close to the Workshop, the Workshop Leaders reserve the right to make the executive decision for the collective safety of all participants in the group. If the Workshop Leaders are forced to cancel the Workshop, the participant's entire tuition will be transferred to another Workshop.

### TRAVEL INSURANCE:

The Workshop Leaders are not liable for any cost associated with travel, lodging, insurance, health emergencies, equipment rentals, or incidental losses incurred in the event of a Workshop cancellation, or if the participant withdraws from the Workshop for any reason. While the participant is not required to purchase travel insurance, it is strongly recommended.

UNDER-SUBSCRIPTION: The Workshop requires a minimum of 7 participants, and will be confirmed once the minimum number is reached. In the event that the Workshop Leaders do not sell out or reach a minimum number of participants, they reserve the right to cancel the Workshop. In this case, a full refund will be given. The Workshop Leaders are not liable for any cost (insurance, flight ticket, camera rental, etc.) the participant might have incurred before the confirmation of the Workshop.

### Privacy Policy

The Workshop Leaders respect the participant's privacy and do not tolerate spam. The Workshop Leaders will never sell, rent, lease or give away the participant's information (name, address, e-mail, phone number) to a third party. When the participant signs up for the Workshop via the Workshop Leaders' website or communicates with the Workshop Leaders, the participant opts into our newsletter and communication. If the participant would like to unsubscribe, they may do so at the bottom of an email with the click of a button.

- The Workshop Leaders reserve the right to take photographs or videos during the operation of any expedition or part thereof and to use the resulting photography for promotional purposes. By making a reservation with the Workshop Leaders, participants agree to allow their images to be used in such photography; participants who prefer that their image not be used are asked to identify themselves to the Workshop Leaders at the commencement of their trip.
- The tour is always dependent on the weather, as the weather can be highly unpredictable in the Lofoten Islands, especially at this time of the year.
- The Workshop Leaders cannot be liable for any loss, damage, accidents, injuries, or sickness during the tour. The same applies to any changes in the tour schedule due to weather, strikes, or any other force majeure. The Workshop Leaders reserve the right

to change routes, schedules, and itineraries if needed because of weather, road, and/or boat route conditions or should the necessity arise because of unforeseen reasons. It is advised for all participants to purchase comprehensive travel insurance to minimize possible losses due to unforeseeable situations during their travel.

- The participant acknowledges that this Workshop may require walking in subzero temperatures. The participant should be in good health. The participant must inform the Workshop Leaders of any severe health conditions that may impact their ability to participate in a planned tour. The participant is responsible for appropriate clothing.
- The participant must bring the minimum required photographic equipment, mentioned in the gear list in order to assure successful participation in the Workshop.
- Before the participant starts the tour, the participant should make sure to have email contact with the Workshop Leaders.
- The participant ensures that the organizer is informed of an emergency contact at the beginning of the trip.
- If the participant has any complaints or comments, the participant can let the Workshop Leaders know as soon as possible via email. The Workshop Leaders value all comments and will try to better themselves where needed.
- This document is final. There are no additional agreements. Verbal agreements, declarations, promises, and guarantees concerning the Workshop shall only become effective in writing.
